ARTICLES OF INCORPORATION  
OF  
POINT WEST ROTARY CLUB FOUNDATION

*Name*

One: The name of this corporation is: POINT WEST ROTARY CLUB FOUNDATION.

*Purpose*

Two: The corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes. Such purposes for which the corporation is organized are exclusively charitable within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (below called "the Code") and more specifically shall be: to establish and maintain a perpetual trust fund to assist in the support of charitable purposes in the Sacramento, California area customarily supported by the Rotary Club of Point West, to encourage avenues of financial support to Rotary Club sponsored charitable projects, and to support other charitable purposes pertaining to Rotary Clubs and their affiliated activities by the distribution of its funds for such purposes, all within the purview of Section 501(c)(3) of the Code, as it may be amended from time to time.

Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Code (or the corresponding provision of any future United States Internal Revenue Law).

*Additional Provisions*

Five: (a) No substantial part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation. The corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

(b) The corporation is not organized, and shall not be operated, for pecuniary gain or profit. It does not contemplate the distribution of gains, profits, or dividends to its members or to any private shareholder, as defined for purposes

of Section 501(c)(3) of the Code, or to any private individual.

(c) The property, assets, profits, and net income of the corporation are dedicated irrevocably to the purposes set forth in Article Two above. No part of the profits or net income of the corporation shall ever inure to the benefit of any director, trustee, officer, shareholder or member of the corporation, or to the benefit of any private individual.

(d) Upon the dissolution and winding up of the corporation, after paying or adequately providing for its debts and obligations, its remaining assets shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for charitable purposes and which has established its tax-exempt status under Section 501(c)(3) of the Code and which is qualified for exemption from taxation under Section 23701d of the California Revenue and Taxation Code.
